-- OFFICIAL SWEEPSTAKES RULES --

NO PURCHASE IS NECESSARY TO ENTER OR WIN. MAKING A PURCHASE WILL NOT IMPROVE ENTRANT'S ODDS OF WINNING.

1. OVERVIEW: JSR Strategies will conduct a random drawing from among all eligible entries received during the sweepstakes period (**October 29, 2024, at 12:00 AM Pacific Time through January 13, 2024, at 11:59 PM Pacific Time**) (the "Entry Period"). Entries submitted before or after the Entry Period will not be eligible. Random drawing of three (3) potential winners will be conducted by **JSR Strategies** (the "Sponsor") on **March 14, 2025** (with Entry Period, the "Sweepstakes"). Sponsor's computer is the official timekeeping device for the Sweepstakes. The odds of winning depend on the number of eligible entries received. The odds of an entry winning will be the same for any method of entry. Limit one (1) entry per customer residence or place of business.

2. PRIZES AND APPROXIMATE RETAIL VALUES:

a. PRIZE DETAIL

a. No purchase or payment of any kind is necessary to enter or win the Sweepstakes. A purchase or payment of any kind will not increase your chances of winning.

b. All entries become the property of **JSR Strategies** and will not be acknowledged or returned.

c. Void where prohibited by law.

d. All federal, state and local laws and regulations apply. No substitution or transfer of Prize permitted.

e. All federal, state and local taxes are the sole responsibility of the winner.

f. You must include your name, represented business (if applicable), phone number and email on the entry form.

g. Failure to comply with this or any other official rule will result in disqualification.

h. Sponsor will attempt to notify the potential winner via phone call or email within five (5) business days of the drawing. If a potential winner does not respond within fifteen (15) calendar days after the notice is sent, the Sponsor will select an alternate potential winner in his/her place at random from all remaining entries received. Only three (3) alternate potential winners will be contacted. Except where prohibited, a potential winner may be required to complete and return an affidavit of eligibility and liability/publicity release. If a potential winner fails to sign and return these documents within the required time period, an alternate potential winner may be selected in his/her place in a random drawing of all remaining entries received.

h. By participating in the Sweepstakes, you agree to release and hold harmless Sponsor, its parent, subsidiaries, affiliates, the prize providers and each of their respective officers, directors, employees, and agents (the "Released Parties") from and against any claim or cause of action arising out of participation in the Sweepstakes or receipt or use of any prize, including, but not limited to: (a) unauthorized human intervention in the Sweepstakes; (b) technical errors related to computers, servers, providers, or telephone, or network lines; (c) printing errors; (d) lost, late, postage due, misdirected, or undeliverable mail; (e) errors in the administration of the Sweepstakes or the processing of entries; or (f) injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Sweepstakes or receipt or use of any prize. i. k. Use of Entrant Information: By entering the Sweepstakes, you acknowledge and agree that Sponsor may use your information, including, without limitation, your email address, phone

number, mailing address, or any other contact information provided for general solicitation, marketing, or other business or promotional activities in connection with the services and products provided by Sponsor or the participating companies. You may at any time revoke the use of such information by providing written notice to Sponsor and each other participating company using the following addresses or by responding to a marketing email using the unsubscribe link provided in the email. Please note that your opt-out preference will apply to marketing communication and may not apply to transactional communication including those associated with your entry.

l. Winner will receive one of three gift cards to Home Depot, value not to exceed \$500.

m. **JSR Strategies** reserves the right to terminate or declare the sweepstakes null and void and rescind any prize if, in its sole judgment, the rules or the integrity of the sweepstakes have been violated or compromised in any way, intentionally or unintentionally by any person, whether or not a participant in the Sweepstakes. In the event that the operation, security, or administration of the Sweepstakes is impaired in any way for any reason, including, but not limited to fraud, virus, or other technical problem, Sponsor may, in its sole discretion, either: (a) suspend the Sweepstakes to address the impairment and then resume the Sweepstakes in a manner that best conforms to the spirit of these Official Rules; or (b) award the Prize(s) at random from among the eligible entries received up to the time of the impairment. Sponsor reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Sweepstakes or to be acting in violation of these Official Rules or in an unsportsmanlike or disruptive manner. Any attempt by any person to undermine the legitimate operation of the Sweepstakes may be a violation of criminal and civil law, and, should such an attempt be made, Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. Failure by Sponsor to enforce any term of these Official Rules shall not constitute a waiver of that provision. Proof of sending any communication to Sponsor by mail shall not be deemed proof of receipt of that communication by Sponsor. In the event of a dispute as to any online entry, the authorized account holder of the email address used to enter will be deemed to be the participant. The "authorized account holder" is the natural person who is assigned to an email address by an Internet access provider, online service provider, or other organization responsible for assigning email addresses for the domain associated with the submitted email address.

n. All decisions of **JSR Strategies** regarding the interpretation of these rules and the decision to award the prize shall be final.
